### TERMS

Payments not received within given terms will result in a 1.8% per month finance charge. Any accounts over 45 days must have the outstanding balance paid in full before any pending orders will ship. Any returned checks for insufficient funds are subject to a \$35 processing fee.

### SHIPPING

All shipping if FOB our warehouse in Ontario, California. Shipping charges are the responsibility of the customer. Please note any discrepancies, damage, and shortages at time of delivery and note these on the Bill of Lading or shipping documents. We cannot be responsible if proper notation is not done within 48 hours of receiving.

### WARRANTY & RETURNS

All returns from retail stores must be done directly through Elevate 420. Distributors must have stores call and deal directly with Elevate 420 for all returns and repairs. Most products are covered by a one-year warranty against manufacturing defects. Specific warranties are expressed in product manuals. All non-warranty and warranty returns must be authorized by Elevate 420 before being sent to us.
